The first **Old Business items** to come before the Board were the Remedial Action Plans submitted by **Jess Construction**, **Inc.** and **The Waterworks**. NEW BUSINESS

DUE PROCESS HEARINGS

The first complaint on the agenda was filed by **Philip Newell**, Construction Inspector I, alleging that **Kyle Morris**, **Inc.** violated City of Columbus Building Code Section 1133.10 (CCC) - 24 hour notice, Work was scheduled for inspection on 1/21/14. Work was completed on 1/20/14. Contractor did not give Permit Office 24-hour notice, Section 108.04(B) Night Work, Work on Sunday and National Holidays. Work was completed on a Holiday without prior approval. Code requires a 72 hour notice in a letter form. 901.04(CMS) - Limit as to Width of Trench. Trench width was only 18". Code requires a minimum of 30" trench. 901.12(CMS) - Laying Pipe, Pipe was installed backwards. Spigot ends were placed upstream instead of downstream. Pipe was installed backwards. Spigot ends wer placed upstream instead of downstream. 915.03 (CMS) Wyes, Fittings and Clean-Outs General Perfrom the insertion of fitting connectors into all pipe sewers in a manner satisfactory to the Engineer & 918.02 (CMS) Sanitary House Connection Service-Materials. Did not use Fernco 5000 Series which is the only adapter approved by the Engineer.

After hearing testimony by license holder **David M. Pritchett** and Inspector **Philip R. Newell** and the evidence presented, **Sam Mascari** made a motion that 24 Hour notice was not given before work began and that the work was done on 1/20/14, a holiday observed by the City of Columbus Department of Public Utilities and a letter with prior approval was not obtained. **Eddie Garrarad** seconded.

Due to the fact that no notice was given and that work was perfomed on a Holiday without prior permission, **Sam Mascari** made a motion to find **Kyle Morris, Inc.** is **guilty** of violating Section 1133.10, 24-hour Notice and Section 108.04(B), Night work, work on Sunday and National Holiday.

Williams Rooter Service.** After hearing the testimony and evidence presented by **Charles Williams**, license holder for **C Williams Rooter Service** and from **Sewer Department Representatives**, **Sam Mascari** made a motion to revoke the Sewer License of **Mr. Charles Williams** based on multiple, persistent and habitual violations of **City of Columbus Code Section 4114.305. Dave O'Carroll** seconded the motion.

After hearing testimony and evidence presented by Jacqueline(Jac) Burley, Jac Burley Trucking, LLC and Jerry Benton, Construction Inspector I, Chairman Baumann made a motion that Jac Burley Trucking, Inc. performed work without giving 24 hour notice. Sam Mascari seconded.
