Pursuant to Columbus City Codes Section 1117.04, the Department of Public Utilities hereby provides notice that the Director has adopted the Land Stewardship Program Permit Schedule and Fees Rule and Regulation. The rule and regulation provides the criteria by which the Director will administer permits associated with approved stewardship activities and improvements for eligible contiguous landowners within the Land Stewardship Program. Pursuant to Columbus City Codes Section 121.05, this rule and regulation will be effective 10 days after this publication.

# OFFICIAL NOTICE RULE AND REGULATION NO. 2022-01 BY ORDER OF THE DIRECTOR OF PUBLIC UTILITIES

### Land Stewardship Program Permit Schedule and Fees

Pursuant to the authority granted under Columbus City Codes Section 1117.04, the Director of Public Utilities hereby adopts, establishes, and publishes this rule and regulation. This rule and regulation shall become effective at the earliest time allowed by law. In addition, nothing in this rule and regulation shall limit the City's ability to seek restitution or required personal property removal and site restoration for any and all types of damage caused by any person to the City's property or due to violation of the provisions of any law, including but not limited to, Columbus City Codes Chapter 1117. Any person participating in the Land Stewardship Program shall be required to adhere to the permit schedule and pay applicable fees as directed below.

### **Permit Schedule**

Permits for a private dock, private stake(s), or paddlecraft storage shall be issued for and valid for a period not to exceed one calendar year beginning 04/01 and ending 03/31.

Permits for a boardwalk, step(s), or stair(s) shall be issued for and valid for a period not to exceed five calendar years beginning 04/01 and ending 03/31.

All permits are non-transferrable.

### **Permit Fees**

- 1. Private dock permits shall incur a fee of seven hundred dollars (\$700.00) to be paid annually with permit issuance or renewal. This shall include up to one vessel that can be docked for the duration of the permit.
- 2. Additional vessels may be permitted with the issuance of a private dock permit and shall incur a fee of twenty five dollars (\$25.00) per paddlecraft or one hundred dollars (\$100.00) per non-paddlecraft to be paid annually with permit issuance or renewal.
- 3. Private stake permits shall incur a fee of one hundred thirty dollars (\$130.00) per stake to be paid annually with permit issuance or renewal. Pontoon boats shall require two stakes.
- 4. Paddlecraft storage permits shall incur a fee of twenty five dollars (\$25.00) per paddlecraft to be paid annually with permit issuance or renewal.
- 5. Boardwalk permits shall incur a fee of one hundred dollars (\$100.00) to be paid every five years with permit issuance or renewal.
- 6. Step permits, for steps in which there are five or more risers, shall incur a fee of fifty dollars (\$50.00) to be paid every five years with permit issuance or renewal.
- 7. Stair permits, for stairs in which there is one stringer, shall incur a fee of fifty dollars (\$50.00) to be paid every five years with permit issuance or renewal.
- 8. Stair permits, for stairs in which there is more than one stringer, shall incur a fee of one hundred dollars (\$100.00) to be paid every five years with permit issuance or renewal.

New private dock customers working through the permitting process shall be allowed to receive a prorated fee for the first year only. Subsequent years are full price. The following prorated rates apply:

- 1. April \$700
- 2. May \$600
- 3. June \$500
- 4. July \$400
- 5. August \$300
- 6. September \$200
- 7. October through March \$100

# **Permit Late Fees**

Any permit renewal that is paid, delivered, or postmarked after March 15 shall incur a late fee of fifty dollars (\$50.00). Any permit renewal that is paid, delivered, or postmarked after May 31 shall incur a late fee of one hundred dollars (\$100.00).
