

NEW: CHILD CARE IMMUNIZATION REQUIREMENTS IN OHIO

The Ohio Legislature recently passed new immunization requirements for children in licensed child care. The bill requires children that are enrolled in a licensed child care facility to be immunized against 14 vaccine preventable diseases, as recommended by the Centers for Disease Control and Prevention. This includes childcare centers, type A family day-care homes, and licensed type B family day-care homes, as well as for children getting child care from a certified in-home aide. It does allow for exemptions for medical and parental reasons.

The Ohio Department of Job and Family Services published the requirements for division 5104.014 of the Ohio Revised Code (ORC) in their updated Child Care Manual. In summary, all children enrolled in child care must have on file a medical statement that contains a record of immunizations, with the month, day and year of each one. Within 30 days of enrollment and every thirteen months after that, the child's caretaker or parent must provide a medical statement indicating that the child has been immunized (or is in the process) against the following diseases:

- 1) Chicken pox
- 2) Diphtheria
- 3) Haemophilus influenzae type b
- 4) Hepatitis A
- 5) Hepatitis B
- 6) Flu (only when available)
- 7) Measles
- 8) Mumps
- 9) Pertussis
- 10) Pneumococcal disease
- 11) Poliomyelitis
- 12) Rotavirus
- 13) Rubella
- 14) Tetanus

VACCINES FOR CHILDCARE WORKERS

Immunization is a lifelong process, and staying up to date protects you, your family, and the kids you serve from deadly disease. Check with your healthcare provider to see if you are fully protected.

- Tdap (Tetanus, Diphtheria, Pertussis) Get a one-time dose of Tdap as soon as possible if you have not received Tdap previously
- MMR (Measles, Mumps, & Rubella) 2 valid doses are needed if you were born in 1957 or later
- Varicella (Chickenpox) 2 valid doses needed unless you have had chickenpox or you have had a blood test that shows you are immune to varicella
- Hepatitis B—3 valid doses needed unless you have had a blood test that shows you are immune to hepatitis B
- Flu (Influenza) Get 1 dose of influenza vaccine annually


MMR and Tdap are required by law for childcare workers.
