- Is a finer, 3/8" screened material
- 'Loamy' texture; earthy brown with flecks of red
- Recommended uses:
  - A great top dressing for lawns (due to fine particle size)
  - A beneficial soil amendment

#### CAN I BE CONSIDERED A 'WHOLESALER'?

Whether a big business, a co-op, or a single-owner operation, YOU CAN open a wholesale account IF you meet the following requirements:

- You do not have an outstanding or delinquent account with Columbus Public Utilities (for Water/Sewer Utility, Com-Til)
- If you bought from us more than 2 years ago, your account was not terminated by Compost Facility
- You agree to purchase AT LEAST 30 cubic yards total product within 12 months - It does NOT need to be purchased all at once!

# HOW DO I OPEN A WHOLESALE ACCOUNT TO BUY COM-TIL?

It's really easy! Just follow these steps:

- Complete a <u>Com-Til Wholesale Account Application</u>
  - Make sure you fill in all necessary information
  - If you can claim an exemption from sales tax, you should also complete a Blanket Exemption Form
  - Check the appropriate options for your account type
- Sign and Date your application on Page 3
- Include a CHECK for your account deposit
  - Make your check payable to "Columbus City Treasurer"
  - Reference "COM-TIL ACCOUNT"
- Mail or email your application to us, or bring it in person!

You can even buy Com-Til the same day your application is received and approved!
