Mr. Kaylor made a motion to certify the results of the applicants who were approved to the Department of Building & Zoning Services for the issuance of a Demolition Contractor's License. Mr. Sintic seconded the motion. **MOTION CARRIED.**

The next item of business to come before the Board was a due process hearing regarding the City of Columbus vs. Ronald Weigand, HIC01227, for a property located at 3951 Snowshoe Avenue. Mr. Weigand was charged with violating Columbus Building Code Sections 4113.37(B), Building Permits Required, 4115.01, Inspections Required, 4115.03, Approvals Required, 4115.04, Inspection Before Covering and 4114.111, Work of a Registered OCILB Licensed Specialty Contractor. He was present for the meeting. Cliff Spruill, City of Columbus Structural Inspection Supervisor, stated in August of 2016, there was a kitchen fire at this address. He also stated a couple months later, the homeowner called to inquire about whether a permit was necessary or not, which resulted in an inspection at this address. He stated the Inspector found all the drywall had been removed and electric and plumbing work had been done and there were no permits pulled for any of the work. He

stated a Stop Work Order was issued on October 17, 2016 and the Building Permit was issued the same day and the Electric Permit was issued on October 27th and the Plumbing Permit was issued on October 25th. He also stated all permits have had final inspections and have been approved. Mr. Weigand stated he did not know he needed to pull a permit for the drywall work or the electric and plumbing work because they only installed a sink and replaced a few receptacles. Mr. Appeldorn made a motion to find that Mr. Weigand did, in fact, begin work before having the necessary permits. Mr. Neverman seconded the motion. **MOTION CARRIED**. Mr. Appeldorn made a motion to find that Mr. Weigand did violate the abovementioned Code sections. Mr. Neverman seconded the motion. **MOTION CARRIED**. Mr. Appeldorn made a motion to take no action against Mr. Weigand's license. Mr. Neverman seconded the motion. **MOTION CARRIED**.

The next item to come before the Board was the review of a Working Without Permit Affidavit for Joshua Greene for a property located at 3513 Beulah Rd. Mr. Sintic made a motion to accept the Affidavit. Mr. Kaylor seconded the motion. **MOTION CARRIED**.
