  - A. To authorize a contract modification to extend the contract period with St. Stephen's Community House for the CelebrateOne Community Connector Corps Project, for a time period ending October 31, 2017.
  - B. To authorize the appropriation of \$503,563.37 in the City's Special Purpose Fund to provide for the continued operations for Health's six special purpose activities: 1) AED Defibrillator Devices 2) Rabies Clinic Program, 3) the Medicaid Provider Incentive Program, or MPIP, 4) Childhood Auto Safety Programs, 5) TB Prevention and Control Program, and 6) the Dental Sealant Medicaid Program.
