Mr. Toops was present for the meeting, however, Mr. Cullen was not in attendance. Mike Roush, City of Columbus Mechanical Inspection Supervisor, stated Mr. Cullen filed the complaint on 3/2/17 against Mr. Toops for repair work to fix a heating/cooling balancing issue in his home. He also stated Mechanical Inspector, Gregg Schultz, did a site visit 3/6/17 and found a new supply air run and a new return air vent had been installed, however, no permits had been obtained for this address. Mr. Toops stated the duct work was existing and the only thing he did was raise the furnace up and tie that in. He also stated he thought this address was covered under Franklin County permitting and not the City of Columbus. He further stated he also did not know he needed to pull a permit for the minimal amount of work that he did in this home. Mr. Walsh made a motion to find that Mr. Toops did not pull a permit for work done at this address. Mr. Witte seconded the motion. MOTION CARRIED-4-0. Mr. Walsh made a motion to find Mr. Toops guilty of violating Columbus Building Section 4113.63, Warm Air Heating and Ventilation Permits Required. Mr. Witte seconded the motion. MOTION CARRIED-4-0. Mr. Walsh made a motion to find that Mr. Toops did not obtain the proper inspections for work done at this address. Mr. Witte seconded the motion. **MOTION CARRIED-4-0.** Mr. Walsh made a motion to find Mr. Toops guilty of violating Columbus Building Code Section 4115.01, Inspections Required. Mr. Witte seconded the motion. MOTION CARRIED-4-0. Mr. Walsh made a motion to find that Mr. Toops did not obtain the appropriate approvals for work done at this address. Mr. Witte seconded the motion. **MOTION CARRIED-4-0.** Mr. Walsh made a motion to find that Mr. Toops did not cover up any work prior to an inspection. Mr. Witte seconded the motion. MOTION CARRIED-4-0. Mr. Walsh made a motion to find Mr. Toops not guilty of violating Columbus Building Code Section 4115.05, Inspection Before Covering. Mr. Witte seconded the motion. MOTION CARRIED-4-0.
