HOT TOPIC:

TIER 2 CHEMICAL INVENTORY REPORTS ARE DUE MARCH 1, 2016

As we are in the midst of another Tier 2 reporting season, please take the time to review the reporting requirements.

Workshops

CEPAC will hold two Tier 2 workshops the last week of January 2016. The purpose of these workshops is to familiarize those who are responsible for Tier 2 reporting with the EPA/SERC reporting requirements. For those that attend, the workshops provide a good opportunity to network, and discuss common and unique reporting requirements for different Tier 2 reporting facilities.

Electronic Reporting Preferred

Electronic Tier 2 reporting is the preferred reporting method. The website to allow for you to get the 2015 Tier 2 submit is: www.epa.gov/epcra/tier2-submit-software. The SERC Compliance Manual and Forms can be found at www.epa.ohio.gov/dapc/serc/invforms.aspx. Paper reports are still accepted.

When you submit electronically, you can send one e-mail to all three reporting places at once. These reports can be sent as pdf's, zip files, compressed files or some other electronic attachment. Your reports go to:

- 3. The jurisdictional fire department for your facility. A separate list of all of Franklin County Fire Departments will be sent out to all Tier 2 filing facilities.

Chemical Database

CEPAC is here to maintain a current SARA Title III chemical database. For the 2014 reporting year, we had 765 reporting facilities. That is up from 718 from the previous year. If you have reportable quantities of any hazardous substance, by law you must report these to the OEPA, LEPC (CEPAC) and your local fire department. For most hazardous substances, the reporting threshold is 10,000 pounds or more stored on site. For Extremely Hazardous Substances (EHS) chemicals, depending on if it is on the EPA/SERC list, it can be as little as one pound. NEW REPORTING POLICY

PSM Retail Exemption Interim Enforcement Policy

October 20, 2015

Employer(s) with employee(s) exposed to PSM-covered processes that had been exempted under OSHA's 1992 interpretation of "retail facility" now must comply with the requirements of 29 CFR 1910.119 if the facility, (or portion of it) processing the highly hazardous chemical, does not fall into the North American Industrial Classification System definition of retail trade (NAICS 44 and 45).

OSHA understands that these facilities, although currently regulated by the EPA under the Risk Management Program (RMP) regulation 40 CFR 68, will need to undertake some new activities to become PSM-compliant. Facilities will need time to initiate needed administrative programs, conduct hazard identification and take any corrective actions. With these factors in mind, OSHA offers this additional guidance for facilities that had been exempted from PSM because of the 1992 retail interpretation.

On July 22, 2015, OSHA issued a revised interpretation to the PSM retail exemption at 29 CFR 1910.119(a)(2)(i). In essence, the revised interpretation states that only facilities in NAICS codes 44 and 45, (retail trade), are eligible for the retail exemption. OSHA believes that nearly all affected facilities are currently regulated by EPA as RMP program level 2 facilities. RMP 2 requires employers to have a safety management system that addresses eight of the 13 OSHA PSM elements.

There may be few added activities needed to comply with PSM, but individual employers must ensure that they have addressed all OSHA PSM elements and sub-elements.

For the first 12 months following the issuance of the Retail Exemption Memorandum on July 22, 2015, OSHA will focus on providing compliance assistance to affected employers, and will inform its State On-Site Consultation Projects that during this period, requests from newly covered employers should take priority for receiving an on-site visit. OSHA now believes 12 months, (vs six originally proposed) will be the time needed because online compliance tools were not available until mid-October and other compliance resources are limited.

OSHA will also refrain from citing employers for violations of the PSM standard at facilities that it would not have cited under the former PSM retail exemption policy. The only exception to this will be if OSHA discovers conditions at a facility that expose workers to an immediate and severe danger, and OSHA determines that the employer has not made a reasonable good faith effort to eliminate or substantially control the hazard. In this rare circumstance, the agency may consider enforcement action to address the immediate and severe danger. Any enforcement action in this situation must be approved by OSHA's National Office.
