## **Standardized Field Sobriety Testing**

"Advanced SFST"



#### **COURSE OVERVIEW**

This 40-hour course includes classroom instruction and controlled exercises structured to give law enforcement officers practical experience in the evaluation of the adverse effects of alcohol/drugs on driving ability. In these exercises, the student is required to observe persons who have consumed controlled quantities of alcohol. Each exercise allows the student to use the most current sobriety testing procedures to evaluate the condition of the drinker.

Classroom subjects include a detailed study of the elements of Ohio (and Columbus) OVI law, the impaired driver problem, enforcement decisions, chemical testing rules and regulations, and arrest procedures. Students will be trained and certified in both the theory and practice of the **2015** Standardized Field Sobriety Testing procedures consisting of the horizontal gaze nystagmus test, walk-and-turn test, and one-leg stand test, as developed by the National Highway Traffic Safety Administration (NHTSA).

#### WHO SHOULD ATTEND

Law enforcement officers involved in the detection, processing, and/or arrest of impaired drivers. **Primary consideration will be given to Field Training Officers,** who are strongly encouraged to attend because all probationary officers receive the 40-hour NHTSA, Standardized Field Sobriety Testing course during recruit training.
