
ADVANCED ROADSIDE IMPAIRED DRIVING ENFORCEMENT (ARIDE) TRAINING

Advanced Roadside Impaired Driving Enforcement (ARIDE) Training

An Advanced Roadside Impaired Driving Enforcement (ARIDE) class will be held at the Chief James G. Jackson Columbus Police Academy, 1000 North Hague Avenue, Columbus, Ohio 43204 on **May 16 - 17, 2018 from 7:00 a.m. to 3:00 p.m**. It is being sponsored by the Columbus Division of Police. Attendance of the full seminar (16 hours) is mandatory to receive certificate of completion.

Any officer attending the ARIDE training shall be a certified SFST practitioner. Two years of experience in administering SFST's is recommended. Officers shall be able to demonstrate their SFST proficiency at the start of the ARIDE training. Both written and practical exercises must be completed successfully to be able to complete this course.

ARIDE was developed by the National Highway Traffic Safety Administration (NHTSA) with input from the International Association of Chiefs of Police (IACP) Technical Advisory Panel and the Virginia Association of Chiefs of Police. ARIDE was created to bridge the gap in training between the Standardized Field Sobriety Testing (SFST) and the Drug Evaluation and Classification (DEC) programs. Recent studies by NHTSA have indicated that nearly 17% of drivers surveyed admitted that they were under the influence of some type of drug while they were driving. This compares with other studies that indicate that 3% of drivers admit being impaired by alcohol.

ARIDE is intended to provide officers with general knowledge related to drug impaired driving and to promote the use of Drug Recognition Expert (DRE) Officers. The ARIDE program also stresses the importance of securing the most appropriate biological sample to identify substances likely causing impairment. The instructors for this course will include DRE officers from the Columbus Division of Police and other agencies. The training also promotes interaction with representatives from the state's prosecution community. Prosecutors are welcome at this training.

In 2010, Ohio was formally recognized by the IACP as having a Drug Evaluation and Classification (DEC) program, which is the foundation upon which the nearly 100 certified DRE officers within our state work. Ohio has already proven its aggressive stance in detecting and evaluating drug-impaired drivers by surpassing almost every other state in the number of enforcement evaluations conducted annually. A proven key to using the DRE officer is preparing all uniformed officers to become aware when in contact with a drug-impaired driver. The ARIDE course was specifically designed for that purpose.

In Ohio, more than 2,500 state, county, and municipal officers have completed the ARIDE course since 2012. These officers, along with DRE officers, have contributed to the arrest of hundreds of drug-impaired drivers. If you miss this training, then you increase the chance of coming to face-to-face with a drug-impaired driver and being unable to recognize obvious signs of impairment.
