

Encryption Checking / Ram Dumping / Live Acquisition

This portion of the class is designed for the first responder, raid team leader, or any other person with the responsibility of conducting search warrants on networks, in the home or at the office. Different types of networks will be discussed ranging from simple home wireless networks to large business networks. Other topics will include proper shut down procedure. Network attached storage devices, obtaining evidence from servers, conducting analysis of routers on scene, etc.

A PC based laptop is useful for the course; however, it is not required for successful completion.



Students will also learn how to develop and use the ISA Investigative Questionnaire, or "IQ". Using the IQ, one investigator can "interview" an unlimited number of suspects at the same time for virtually any offense narrowing the suspect list to only a handful in a matter of minutes.



Richard Lober specializes in training for law enforcement officers, correctional officers and investigators for government agencies. Until his retirement in May 2010, Richard Lober was the Inspector General for Florida's Department of Environmental Protection, which had over 4,000 employees. The Inspector General had independent authority concerning all matters relating to the investigation and review of misconduct, fraud, waste, misuse/abuse and mismanagement of the agency's resources. The Office of the Inspector General became one of the first offices in the Florida to be awarded accreditation for meeting the high standards in conducting investigations as established by the Commission on Florida Accreditation. Mr. Lober was also the Agency Head of Florida's Medicaid Fraud Control Unit – Office of the Attorney General. This 232 person law enforcement agency had statewide responsibility for criminal and civil enforcement of healthcare

fraud & patient abuse. Mr. Lober has served as the Chief Inspector of the Office of Executive Investigations for the Florida Department of Law Enforcement (FDLE). This office, which reported directly to the FDLE Commissioner, handled Governor Ordered investigations, high profile public corruption cases, internal investigations and background investigations of Governor Appointees. Mr. Lober was also an Assistant General Counsel with FDLE and held several other positions with the agency. Prior to joining FDLE, Attorney Lober was General Labor Counsel for the Miami-Dade County Police Beneral content Anterior and was a presenter in the Miami Dade State Attorney's Office. His law Benevolent Association and was a prosecutor in the Miami-Dade State Attorney's Office. His law enforcement career, which began in 1974, included six years as a deputy/sergeant with the Miami

Mr. Lober received his Juris Doctorate in 1983 from Western New England School of Law and began his legal career as a prosecutor with the Miami-Dade State Attorney's Office. He also has a Bachelor of Arts Degree in Public Administration. In 2010, Mr. Lober became a Certified Inspector General Auditor, which was awarded by the Association of Inspectors General. From 2001 - 2003 Mr. Lober served as the Charter President for the Florida Internal Affairs Investigators Association. He is an honorary member of that Association as well as the Miami-Dade County PBA. He also served on the Executive Committee of the Florida Association of Inspectors General

Mr. Lober has been a guest lecturer for numerous criminal justice agencies and associations and has written several published articles. He has also developed numerous training programs and served as adjunct faculty for the Florida Department of Law Enforcement's Executive Institute, the Southern Police Institute, the I.A.C.P., the Florida Inspectors General Institute and the Regional Community Policing Institute at St. Petersburg College

Investigating Citizen Complaints & **Officer Misconduct for Supervisors**

Course Objectives:

Each law enforcement agency is responsible for having an effective and professional process for investigations of complaints made against its officers and employees. Supervisors assigned to investigate such must insure that all internal investigations are handled in a prompt, fair & impartial manner. The public, the accused officer and Agency Leadership expect supervisors/ investigators to effectively deal with performance and/or misconduct incidents. Misconduct investigations are unlike most other investigations and require a fact-finding approach and transparency in order to retain the public's confidence and trust. A police agency must demonstrate to the public and its members that only the highest ethical standards of law enforcement will be practiced by the agency and that the investigation of complaints follow established professional standards. Immediate and proper intervention of potential employee performance or misconduct incidents, at the appropriate level, serves to promote morale within the agency and promotes interaction and support of the community.

Seminar Goals:

1. Attendees will learn the importance of ethical standards for persons assigned to conduct internal investigations of its officers and core values associated with the proper handling of all internal investigations.

2. Attendees will learn about the impact of internal investigations on officers' conduct and ethical decision-making.

3. Attendees will learn the differences between performance matters and serious misconduct and the supervisor's role in handling such incidents.

4. To inform the attendees of the importance of an open, unbiased and responsive complaint intake process and their impact on the process.

5. To define the different types of reviews involving internal reviews of alleged misconduct (complaint review, inquiry, investigation) and achieve the objectives of personnel investigations.

Stress Management in Law Enforcement

Course Objectives:

The Stress Management in Law Enforcement class provides police officers the education, training, and tools necessary to achieve optimal performance and sustain it for a safe, long and healthy career. Participants will gain an understanding of WHAT stress is and will be introduced to the stress-performance relationship and its impact on one's physiological, mental, and emotional state. Further, training will provide police officers a greater insight into how stress immediately impacts cognitive function (especially during critical incidents) such as the decision-making process and level of attention, both critical components of law enforcement.

Through the knowledge gained in the class and applied biofeedback training, officers will gain new skills to regulate the stress response on command. In addition, police officers will complete a Stress Management Continued Care Plan which can help participants gain a range of benefits impacted by stress such as lower resting heart and blood pressure, decreased muscle tension, improved immune function and ability to fight illness, improved cognitive function (i.e. faster and more accurate decision making skills, improved analytical processing, and improved memory), improved emotional state and a reduction in cumulative PTSD, decreased frustration/anger and overall improved wellness. Officers completing the course will gain immediate takeaways for improved sleep, work-life balance, and more critically, enhanced function for a safe and long career in law enforcement.

Upon course completion, police officers will be able to:

- Focus and concentrate with sharpness amongst distractions
- Learn to achieve an optimal state of activation depending on the situation
- Realize a heightened level of self-awareness
- Self-Regulate more effectively and efficiently in order to achieve maximum performance and sustain it
- Be more resilient in high stress, high pressure situations, over longer periods of time
- Make better instinctive and intuitive decisions
- Learn to regulate stress on command and decrease the potential for "reacting" and rely more on "acting" (i.e. shoot/don't shoot)
- Enhance their overall physical, mental and emotional wellness
- Sleep with more ease and achieve a better work-life balance
- Reduce the effects of cumulative PTSD

•To provide the most up-to-date legal and generally accepted practices foundation for employee discipline and the conduct of administrative investigations

•To provide successful candidates with industry recognition for engaging in personal and professional development in this essential public safety task

Certification Validity:

Certification will be valid for three (3) years. The successful candidate will receive special recognition for this achievement. During this three (3) year period, each successful graduate will be provided with a regular update bulletin in either printed, electronic or CD format.

Certification will provide the opportunity for networking with other nationally Certified Internal Affairs Investigators. This allows certified members to share information and discuss issues in conducting internal and administrative investigations.

Re-Certification:

Human trafficking exists in the United States and can be considered Modern Day Slavery. Worldwide, it is a \$150 billion criminal industry and it is found in every state of the United States. As many as 300,000 children in the US are at risk for sexual exploitation on a yearly basis.

Law Enforcement Officers may encounter a human trafficking operation during the course of their duties: during a traffic stop, during a police raid or even through a walk-in complaint. These situations often lead to the rescue of a human trafficking victim.

Ambush & Lethal **Environment Recognition Training** (A.L.E.R.T.)

Course Objectives:

Randy has recognized the need to mitigate the growing trend of injuries and deaths related to targeted ambush/ surprise encounters against law enforcement personnel and has developed a training program to counter those trends. These learned skill sets will dramatically enhance and improve the law enforcement officer's Awareness and Threat Detection (ATD) capabilities. The training helps law enforcement officers thwart potential ambush situations and turn them from a disadvantage into a tactical advantage. It benefits officers during routine patrol, special events, traffic stops etc. and protects him/her from ambush-type situations. The training teaches officers methods to accurately assess violator/public contacts and gives the officer the ability to predict the potential for an encounter to escalate into a threatening event.

The program is designed to directly enhance the Law Enforcement personnel capabilities in advanced threat awareness skills and allows an aggressive approach to observe and identify booby traps, IED's and threats in a multitude of environments through threat indicators that exist in the human and terrain atmosphere. The program teaches officers how to establish baselines in their environment and how to recognize certain anomalies that indicate potential threats through human behavior, body language and ground sign awareness.
