 - Partnered with Columbus Fire, referred to all opioid overdoses in Franklin County.

 - The fire department is funding a program that allows paramedics to do regular home visits in an effort to lower readmission rates to surrounding healthcare organizations
 - Patients are referred to the fire department from a variety of sources (i.e. doctors, churches, food pantries, schools, apartment complexes)
 - Paramedics complete needs and safety assessment, and work with doctors over the phone
 - Staff undergo monthly training
 - The program has collaborated with ADAMH, and has been quite successful thus far
