Election days:

- Primary election - May 7, 2019
- General election - November 5, 2019

State law required filings:

- 2018 Annual Report - January 31, 2019
- Pre-Primary Report - April 25, 2019*
- Post-Primary Report - June 14, 2019*
- Semiannual Report - July 31, 2019**
- Pre-General Report - October 24, 2019
- Post-General Report - December 13, 2019

*Note - the Pre-Primary & Post-Primary Reports are not required for candidates running for an office that will not appear on the Primary Election ballot.

**Note - the Semiannual Report is required to be filed with the Franklin County Board of Elections only if the candidate did not file a Post-Primary Report & if the candidate had contributions exceeding \$10,000.

City Code required filings:***

- Mid-Cycle Report - March 8, 2019
- Primary 5 Day Report - May 2, 2019
- Semiannual Report - July 31, 2019****
- Mid-Cycle Report - September 6, 2019
- General 5 Day Report - October 31, 2019

***Note - If the candidate or ballot issue committee had contributions or expenditures less than \$1000 for a filing period, a Notice of Exemption from Filing report must be filed with the City Clerk's Office.

****Note - the Semiannual Report is required to be filed with the Columbus City Clerk only if the candidate or ballot issue committee did not file a Post-Primary Report & if the candidate or ballot issue committee had contributions or expenditures equal to or exceeding \$1,000 for the period.
