

LFAP Review

The Issue: No comprehensive plan for Columbus and Franklin County to address the food system as a whole

Purpose: To champion a community effort to create a stronger, more sustainable local food system

Vision: A fair and sustainable food system that benefits our economy, our environment and all people

A Life Long Gardener



- Learned to garden from Charles Nabrit and Washington Penn (Dad & Granddad)
- Often unwillingly, over the course of many, many,Saturday mornings and summer vacations.

Introduction

- I was born May 9th 1980.
- I am the oldest of three boys, and eight grandkids (7 boys, 1 girl)
- I have a twin brother Damon, and a younger brother Evan.
- I am not married, and do not have kids.

"High School"

- I was home schooled from 5th grade until I went to college. And in case you were wondering, no I did not enjoy the experience. Picked college that was >8hr drive from Columbus.
- Most of my instructors were African or African-American Graduate students at The Ohio State University.
- Being home schooled did allow me to travel to Asia, Europe, and about 40 of 50 states before graduating.
- I also volunteered extensively at my church and COSI, where I earned a lifetime membership for volunteering over 3,000 hours. I trained the rats to play basketball.
- I participated in sports through the Columbus Parks and Recreation Centers.

College

- Political Philosophy Major
- Resident Advisor, Urban Action
 Coordinator, and Discipline Committee
- Worked at every restaurant near campus doing delivery and managed student café
- Walked onto the fencing team, 2000 lvy league champions
- Volunteered in Trenton, creating gardens

After College

- My family went on a book tour across the country to promote "Morning by Morning"
- Dad stepped on a nail in 2004, which led to a cascade of health crises.
- Came home to Columbus to help out, worked as a grant writer.
 Wrote a charter school grant and opened a vocational high school in Springfield, OH. Serving at-risk and adjudicated students 16 to 21 years of age who had dropped out of school for 2 years of more.
- Began working at an after-school and childcare center at my church, eventually becoming a licensed center director. Worked with about 125 children, 2 to 12 years of age with 20 staff members.

Growing Community

- My dad controlled his diabetes for 10 years with diet alone.
- Taking my dad to dialysis and physical therapy really drove home the importance of nutrition and how inequitable access was effecting the health of my community.
- Created garden in 2013 as free grief therapy, but it became a place of healing, teaching, growing community.
- Co-manager of the CMN Memorial garden, a 4,000 sq. ft growing space arranged in 40+ raised beds that supply our onsite farmer's market Wed. 4-7pm and Sat. 10-12, we sell all our produce for \$1/pound.





Greater Columbus Growing Coalition G.C.G.C.

- Joined GCGC in 2014, became Vice President in 2015, and have served as President since 2016.
- The group has grown from roughly 125 members to over 300 in the last two years
- Known for our flower drops, where we distribute plants donated by Strader's Nursery. We had over 75 truck loads of deliveries in 2017.
- We also work to advocate for civic agriculture and strengthening the local food system.
- We have increased the number of mini grants we award to members to 10, we now award \$2500 annually.
- We provide limited general liability insurance for our community gardens.












