Incident Summary: On April 11, 2019, at 9:32PM, Columbus Police Patrol Officers responded to 1760 S. 8 th Street on the report of a shooting. Upon arrival, Officers located the victim, John Doe, inside the residence of 1765 S. 8 th Street suffering from a gunshot wound, and another victim, Mr. Yashuwa Watson, lying on the sidewalk with a gunshot wound. The victim inside the residence, John Doe, was pronounced deceased at scene by CFD Medic #2 at 9:42PM. Mr. Watson was transported by CFD Medic #14 to a local area Hospital in critical condition; however, he is expected to recover from his injuries.				
Update: John Doe's identity has been confirmed and Next of Kin notifications have been made. The deceased victim has been identified as Te'marr Wallace.				
Investigators are still trying to determine a motive for this incident.				
This is the 27 th Homicide in Columbus, Ohio in Calendar Year 2019. Detective David Phillips is the lead on this case being assisted by Det. B. Sheline. The investigation continues.
