Project: Parsons Avenue Public Art Project: *A Thousand Eyes*

Location: Parsons Avenue right of way between Broad and Oak Streets

On April 24, 2018, the Columbus Art Commission (CAC) conceptually approved *A Thousand Eyes*, a public art proposal by artist, Olga Ziemaska. Ziemaska is the CAC approved artist for the Parsons Avenue Public Art Project. The Columbus Public Art Program, in cooperation with the Columbus Department of Public Service (DPS), has collaborated to integrate public art into a section of Parsons Avenue between Oak and Broad Streets. As part of an ODOT project to redesign the downtown portions of I-70 and I-71, DPS will be placing utilities underground and redesigning the streetscape in this portion of Parsons Avenue. Olga Ziemaska was selected thru a statewide call for artists.

Ziemaska is returning to the CAC to request Final Approval of *A Thousand Eyes*. The artist will be presenting drawings of the art, material samples, a letter of support from the Department of Public Service, and maps showing artwork locations.

Note: Applicant must receive right of way permits from the Department of Public Service to place the artwork in the right of way.

Location: North side of Gay Street in front of the Beacon Building (50 W. Gay St.)

Applicants are returning with the final design and plans for the Gay Street charging station and requesting Final Approval. Applicants received Conceptual Approval from the CAC on 4/24/19. The Applicant Team attended two previous Commission hearings discussed the project as Preliminary Project Discussion agenda items on 10/23/18 & 1/22/19. SMART Columbus, working with the Department of Public Services, engaged CCAD professors and students in developing design proposals to convey the exterior of EV charging stations into public art. Commissioners have engaged in discussion about the project and had an opportunity to see project issues as identified by student proposal teams.

Location: A grass area in the public right of way at the southwest corner of Town and Gift Streets, adjacent to the Pilot Dog Inc. building in Franklinton

Artist: Andrew Lundberg, Lundberg Industrial Arts

Applicant is before the CAC to request final approval of a sculpture by artist Andrew Lundberg to celebrate the upcoming 70th anniversary of Pilot Dogs, Inc. Since 1950, Pilot Dogs has served sightless individuals and trained pilot dogs on the sidewalks of Franklinton and Downtown. The artwork mold was shipped to American Bronze Foundry in Sanford, Florida where it has entered the casting phase of fabrication.
