Incident Summary: On December 9, 2019 at approximately 6:04 p.m., Columbus Police officers were dispatched to a shooting at 3556 Seabrook Avenue. Upon the officers' arrival they located Latisha Jones inside the residence suffering from multiple gunshot wounds. Ms. Jones stated she was moving out of the residence when her ex-boyfriend, Norman Watkins Jr., showed up and began damaging her property. She added a fight broke out between Mr. Watkins and another individual. After the fight ended Mr. Watkins called additional people to the house. Witnesses interviewed at scene stated and one of the unknown individuals Mr. Watkins called to the house, began shooting into the residence, and that is when Ms. Jones was struck by the gunfire. The unknown suspect fled the area after the shooting. Ms. Jones was struck in the right leg and right chest area by the gunfire. She was transported to Mt. Carmel East Hospital and is currently listed in stable condition.

Mr. Watkins Jr. was arrested on Domestic Violence charges stemming from this incident that occurred prior to the shooting.
