Incident Summary: On January 12, 2020 at 4:22PM, Patrol Officers responded to 6391 Georges Creek Drive on the report of a vehicle striking a building. Initial investigation indicated that witnesses heard gunshots immediately preceding the accident and upon arrival, Officers found the vehicle engulfed in flames and summoned CFD. Once the fire was extinguished, further investigation revealed the presence of the victim, later identified as Savon Pullie, inside the vehicle. Mr. Pullie was pronounced deceased at 4:35 p.m. It was also learned, that a second victim, Todd Hammond Jr., was also in the vehicle at the time of the shooting and when the vehicle struck the building. Mr. Hammond fled on foot after the accident, and suffered only minor injuries.					
***UPDATE***: Columbus Police Homicide Detectives have filed a Murder warrant against Darnell Rashawn Walton in the death of Savon Pullie. The whereabouts of Darnell Walton are still unknown and he should be considered "armed and dangerous".					
The investigation continues. This is the 8th Homicide in the City of Columbus in 2020.
