Incident Summary: On Monday, February 3, 2020, at approximately 7:46 p.m., Columbus Police Officers were called to 1422 E. Livingston Ave. on the report of gunfire. Upon arrival, Officers found an injured male, lying in the parking lot, suffering from an apparent gunshot wound. CFD Medic 815 responded to the scene and transported the victim, later identified as Jeremiah Lavell Williams, to Grant Medical Center in critical condition. At 8:34 p.m. Jeremiah Williams succumbed to his injuries and was pronounced deceased by attending physicians.

Officers also located two additional victims at the scene, later identified as Anthony Marcell Williams Jr. and an unnamed juvenile. Both were transported to Grant Medical Center suffering from apparent gunshot wounds. Initial investigation revealed that an argument occurred in the parking lot involving a large group of people, when the altercation escalated resulting in all 3 victims being shot.
