Incident Summary: On February 3, 2020, at approximately 10:41PM, a female approached uniformed officers in the area of Kelton and Livingston and advised them that a female at 1127 E. Livingston Ave had been killed. She also advised that she knew the whereabouts of the suspect. Patrol officers responded to 1127-A E. Livingston Ave and found the victim suffering from multiple stab wounds. The victim was pronounced deceased at 11:13PM by CFD Medic 815. The suspect, Mr. Brian Belton, was located at 3006 E Main St., where he was apprehended without incident. Mr. Belton was transported to Police Headquarters for processing. Mr. Belton was charged with Murder for the death of the victim, and he was then transported to the Franklin County Jail.
