


## 2019-2020 Columbus & Franklin County Seasonal Influenza Activity Weekly Summary (Week 5, Jan. 26<sup>th</sup>, 2020– Feb. 1<sup>st</sup>, 2020)

### Highlights

- In week 5 of 2020, once again the vast majority of individual flu activity indicators increased compared to last week. As a whole, local flu intensity (composite indicator) continued to increase and is HIGH.
- Geographic spread and local intensity designation (Click [here](#) for definitions) = WIDESPREAD, HIGH
- Local medical facility labs reported 3,367 tests run with 1,132 (33.6%) positive results for week 5 of 2020.
- The percentage of ED visits for both influenza-like-illness (ILI) and respiratory symptoms increased compared to last week.
- In week 5 of 2020, the trends for individual local over-the-counter medication category sales tracked generally increased (decrease in adult anti-fever sales; increase electrolyte, thermometer, chest rub, pediatric anti-fever and throat lozenge sales; stable cough and cold sales) compared to last week.
- In week 5, U.S. key indicators that track flu activity remain high and, after falling during the first two weeks of the year, increased over the last three weeks. Please [visit the CDC website for specific information](#).

## **Influenza Morbidity and Influenza-Like Illness (ILI) Reports**

In week 5, the preliminary Ohio<sup>1</sup> (statewide) influenza and influenza-like-illness (ILI) visit rate to athenaHealth® primary care providers (51.2 per 1,000 visits) increased compared to the previous week and is above its baseline average for the week (Figure 1). The week 5 percentage of all Emergency Department (ED) visits categorized as ILI increased compared to the previous week (Figure 3) and is above its historic baseline for the week.

Nationally, during week 5 of 2020, 6.7% of patient visits reported through ILINet were due to influenza-like illness (ILI). The percentage is above the national baseline of 2.4% for week 5.

## **Laboratory Surveillance**

During week 5 of 2020, reporting Franklin County sentinel medical facility laboratories tested 3,367 specimens, with 1,132 (33.6%) positive (Figure 4). The total number of tests done by local reporting labs from week 35 of 2019 through week 5 of 2020 is 36,934 with 6,934 (18.8%) positives (2,097 type A, 4,783 type B, 0 type A and B, 54 type unknown).

Nationally in week 5 of 2020, clinical laboratories reported 53,247 specimens tested for influenza viruses, 15,875 (29.8%) of which were positive (8,637 type A, 7,238 type B). In week 5, public health laboratories reported testing 2,129 specimens, 1,365 of which were positive (898 type A – of which 810 were A(H1N1)pdm09, 36 were H3N2, and 52 were not subtyped; 467 type B – of which 2 were Yamagata lineage, 393 were Victoria lineage, and 72 where lineage was not performed). In week 5 of 2020, Ohio clinical labs reported 50,414 specimens tested for influenza this season thus far. Positive results include: (215) A(H1N1)pdm09; (3) A/H3N2; (3,278) Flu A Not Subtyped, and (5,900) Flu B (through 2/1/2020). In week 5 of 2020, ODH Public Health Lab reported 428 positive influenza tests from various submitters this season so far. Positive results include: (195) A(H1N1)pdm09; (15) A/H3N2; (218) Influenza B (through 2/1/2020). Please visit the ODH website for more information.

## **ED Respiratory Visits**


**Figure 5: Franklin County Resident Respiratory ED Visits, 2019-20, Franklin County, OH**

In the 5<sup>th</sup> week of 2020, the percentage of all ED visits categorized as respiratory increased compared to the percentage seen the previous week and is above its baseline for the week (Figure 5).

## **Over-the-Counter (OTC) Medication Sales**

In week 5 of 2020, the trends for individual local over-the-counter medication category sales tracked generally increased (decrease in adult anti-fever sales; increase electrolyte, thermometer, chest rub, pediatric anti-fever and throat lozenge sales; stable cough and cold sales) compared to last week.





**Figure 1: Ohio Outpatient Primary Care Provider Influenza or Influenza-Like-Illness Visit Rate\***







**Figure 3: Franklin County Resident ILI Defined\*\* ED Visits, 2019-20, Franklin County, OH**





**Figure 4: Percentage of Local Reporting and National Laboratory Positive Influenza Tests by Week, 2019-20**


