Incident Summary: On February 8, 2020, at 11:36 a.m., the suspect entered the Huntington Bank located at 3931 Morse Crossing and approached the teller counter yelling at tellers, "Give me some money, I have a gun, I do not want anyone to get hurt." Suspect was given an unknown amount of cash and fled the scene. Suspect was seen getting into the passenger side of a white vehicle, possibly a hatchback bearing an unknown Ohio tag.			
At 12:09 p.m., the same suspect entered the Kemba Financial Credit Union located at 4311 N. High St and approached the teller counter and demanded money from the tellers, stating he had a gun. Suspect was given an unknown amount of money and fled the scene in a white SUV with driver side front end damage.			
The suspect was described as a male white, 5'6" to 5'8", skinny, 125-150 lbs., blueish/hazel eyes, wearing a black hoody with a "clown-type" logo on the back with white lettering on the back and front, black half-mask, light colored blue jeans, black shoes, carrying a black backpack.
