Incident Summary: On Tuesday, February 18, 2020, at approximately 8:40 p.m., Columbus Police Officers were called to 5570 Applefair Drive on the report of a shooting. Upon arrival, Officers found two injured males, inside the residence, suffering from apparent gunshot wounds. CFD Medic 31 pronounced one victim, later identified as Jacob Isaiah Todd, deceased at 8:52 p.m. Prairie Twsp Medic 244 transported the other victim, later identified as Souleymane Gadio, in serious but stable condition.

*****UPDATE***** On February 19, 2020, Homicide Detectives filed the above charges on the suspect, fully identified as German Sanchez Jr., for the Murder of Jacob Todd and the Shooting of Souleymane Gadio.

*****2nd UPDATE***** On February 25, 2020, Mr. Sanchez appeared at Columbus Police Headquarters and turned himself in.
