Incident Summary: On May 31, 2020, at approximately 1:00am, Columbus Police Officers were dispatched to Greenlawn and S. High St. on a shooting. Upon arrival, Officers located the victim suffering from multiple gunshot wounds. The victim, who was later identified as, Mr. Jeffrey Devin Long, was transported to a local area hospital in critical condition. Mr. Long soon after succumbed to his injuries, and he was pronounced deceased at 1:39am. The victim and the unknown assailant were engaged in a physical confrontation shortly before the shooting.

This is the 43rd Homicide in Columbus Ohio in Calendar Year 2020. Incident #200391102. Detective Shane Karnes is the lead detective on the case being assisted by Detective Jennifer Gribi. The investigation continues.

Update: 6-16-2020: The suspect in this Homicide has been fully identified as Mr. Reginald DeJarnett Jr., and a murder warrant was filed for his arrest. Mr. DeJarnett turned himself into Police Headquarters, and he was placed into custody without incident. Mr. DeJarnett was slated at the Franklin County Jail.
