Incident Summary: On January 7, 2020, at 10:00PM, Patrol officers were disptached to 1137 Smith Rd on the report of shots fired. Upon arrival, officers located the victim suffering from gunshot wounds lying in the driveway of 1137 Smith Rd. The victim suffered fatal gunshot wounds, and he was pronounced deceased by CFD Medic #14 at 10:11PM.						
Initial investigation revealed that there were multiple shots fired and vehicles were struck in the exchange of gunfire. Investigators are still attempting to determine the motive for this incident.
