**Project:** [Linking Together Public Art Project](#)

**Location:** Weinland Park, on the Fourth Street side of the linked fence surrounding the basketball courts.

**Applicant:** University District Organization

The University District Organization (UDO) proposes to install a temporary public art project on a portion of the linked fence surrounding the basketball court at Weinland Park, located adjacent the Weinland Park Elementary School between Summit and Fourth Streets. It is proposed to be in place, between four to seven months. It is one of two installations. The other installation will be on a similar, privately owned, linked fence at the intersection of W. Norwich Avenue and N. High Street. The artist, D'nyhn M. Carter is called *Conceptual Thoughts/Inspiration*.

The applicant is scheduled to discuss the art installation with Recreation and Parks representatives on September 15. Staff will report their position at the hearing. No issues are anticipated.
