Incident Summary:

UPDATE – On Thursday, October 8, 2020, Mr. Bullock turned himself in and was slated at the Franklin County Jail.

UPDATE - Columbus Police Homicide Detectives have filed an arrest warrant for David Bullock. Mr. Bullock has been charged with Murder for causing the death of Mr. Clayborn.

On Friday, October 2, 2020, at 1:58AM, Columbus Police Officers were called to the area of 1751 Parsons Ave. on a ShotSpotter alert. On arrival, officers found Ms. Blair Ray in front of 1743 Parsons Ave. suffering from an apparent gunshot wound. Inside of 1743 Parsons Ave., officers found Mr. Andre Clayborn who was also suffering from an apparent gunshot wound.

CFD Medic 2 transported Ms. Ray to Grant in critical condition. CFD Medic 3 transported Mr. Clayborn to Grant in extremely critical condition. Mr. Clayborn did not survive his injuries and was pronounced deceased by attending physicians at 2:33AM. While the first two victims were being treated, a third victim, Jarrett Gordon, arrived at Grant. Mr. Gordon was also wounded during the incident and is expected to recover from his injuries.

While it hasn't been determined what precipitated the altercation, the investigation has revealed a number of shots were fired both inside and outside of 1743 Parsons Ave.
