Incident Summary: On September 11, 2020 at approximately 3:00 a.m., LYFT driver/victim Mr. Ogondi picked up a customer/suspect in the area of Reynoldsburg-New Albany Rd. The suspect insisted for Mr. Ogondi to drive him to several places not origionally requested. When Mr. Ogondi refused, the suspect pulled out a gun, held it to Mr. Ogondi's head stating "you will drive me to where I tell you to go." For approximately 2 to 3 hours Mr. Ogondi was forced to take the suspect to several places in the area of E. Livingston Ave and Noe-Bixby Rd. Finally, when Mr. Ogondi stopped to get gas at the Shell Gas Station located at 5989 E. Main St he was able to escape from the suspect. The suspect was last seen walking away from the Shell Gas Station northbound on McNaughten Rd. Mr. Ogondi was able to return back to his vehicle and call the police.			
The suspect was described as a: black, male, 30-35 yrs. old, bald, black goatee and mustach, 5'7", 170lbs, wearing a black t-shirt, black/gray sweat pants, and displayed a black handgun.
