Incident Summary: On January 1, 2021, Columbus Patrol Officers responded to 928 Muirwood Village Drive on a domestic dispute. Upon arrival, they were directed to 885 Danwood Drive. Upon arriving at this location, officers heard multiple gunshots coming from 885 Danwood. Officers made entry and found the two victims suffering from gunshot wounds. They also found the suspect, who was suffering from a self-inflicted gunshot wound. The suspect was later pronounced at scene by Medic #192 at 11:32PM. The two victims were transported to Doctor's West Hospital and eventually succumbed to their injuries, and were pronounced by attending physicians at 12:07AM and 12:43AM. This incident is still under investigation.
