| On Wednesday, January 27, 2021, at 2:23PM, Columbus Police Officers were called to 45 Rodgers Ave. on a report of a shooting. On arrival, officers found a 20-year-old male suffering from an apparent gunshot wound. CFD Medic 10 responded to the scene and pronounced the male deceased at 2:29PM. The circumstances that led to this shooting are still under investigation. The decedent's name is being | | | | | |
