Incident Summary: *****Update - February 21, 2021: The victim of HOM21-0029 has been identified as Melly Mel Marquise Smith M/B/27YOA.**** On February 18, 2021, at 1:09AM, Patrol Officers responded to the area of 1936 Fountainview Ct on a shooting. Upon arrival, Officers located the victim, John Doe M/B/27, who was outside in the common stairwell of 1944 Fountainview Ct., suffering from gunshot wounds. The victim was transported to a local area Hospital by CFD Medic #23, despite the life saving measures he received, he succumbed to his injuires and was pronounced at 3:11AM. The suspect, Mr. Amir Elkhabiry M/B/23, was located in the area by patrol officers and taken into custody. The suspect was charged with murder for the death of the victim. At this time, what is known to investigators, the suspect and victim were involved in some type of altercation, where the victim was shot by the suspect.
