Incident Summary: ****Update - February 24, 2021: The victim of Homicide 2021-0031 has been identified as Josie Papay Kamara M/B/27 YOA.****

On February 21, 2021, at 4:22am, Patrol Officers were dispatched to an unknown complaint, with a possible shooting in the area of 3566 Greenwich St. Upon arrival, Officers located the victim inside of 3572 Greenwich St. suffering from a gunshot wound. The victim was transported to a local area hospital by CFD Medic #62 in life threatening condition; however, despite life saving measures, the victim was pronounced at 8:03am by attending physicians. At this time, it appears, that there was a party taking place at the Greenwich St. location when an argument erupted and an unknown person began firing a weapon inside the apartment.
