Incident Summary: **Update March 21, 2021: The deceased/suspect has been identified as Mr. Allen Lester McKinney M/B/36. Mr. McKinney was in the process of committing an Aggravated Burglary Offense when he was shot by the resident. Mr. McKinney died as a result of his injuries obtained during this offense. ******

On March 20, 2021, at 1:58AM, Patrol officers responded to 3484 Wilson Woods Dr Apt H on a shooting. Upon arrival, Officers located the suspect outside on the walkway unresponsive and suffering from an apparent gunshot wound. CFD Medic #12 pronounced the suspect at 2:07AM. The victims advised that the suspect forced entry into their home, at which time the shooting occurred.

Upon completion of this investigation, it will be sent to the Franklin County Prosecutor's office for Grand Jury review.
