## Incident Summary:

\*\*\*UPDATE - The 19-year-old decedent's next of kin have been notified. The 19-year-old victim was Nickolas Cowans.\*\*\*

On Saturday, April 3, 2021, at 2:43PM, Columbus Police Officers were called to 931 Eaton Ave. on a report of a shooting. On arrival, officers found 24-year-old Kevin Williams, 30-year-old Anthony Williams and a 19-year-old male all suffering from apparent gunshot wounds.

CFD Medics transported both Kevin Williams and the 19-year-old to Grant Medical Center in critical condition where Kevin Williams was pronounced deceased at 3:46PM and the 19-year-old was pronounced deceased at 5:44PM. Meanwhile, CFD Medics transported Anthony Williams to an area hospital where he remains in critical condition.

The name of the 19-year-old is being withheld pending notification of next of kin.
