On March 17, 2021 at approximately 12:08 p.m., Columbus Police Officers were dispatched to the area of E. Livingston Avenue and Beechwood Road on a report of a shooting. Upon arrival, officers made contact with the victim, 63-year-old Donald Anderson, at the Eagle Gas station. Anderson was suffering from gunshot wounds to the chest and to the neck. Witnesses told officers that he had walked in front of a vehicle as he was walking in the parking lot of the business. He stated an unknown male exited the driver's side of a gray Honda CR-V and fired multiple gunshots, striking him. Anderson was transported to a local hospital in critical condition, and was later upgraded to serious condition.
