Incident Summary: \*\*\*UPDATE\*\*\* Evidence in this case lead investigators to filed a Warrant for Murder on Clyde Littlefield for the death of Edward C. Hunter. Investigators also filed a weapons charge on Logan Besse who is also a person of interest in this case. On July 1, 2021, at approximately 2:08am, officers were dispatched to 945 Sullivant Ave on the report of a shooting. Officers arrived at scene and discovered the victim suffering from a gunshot wound. Columbus Fire Medic #890 responded to scene and pronounced the victim deceased at 2:16am. Witnesses at scene stated there was an altercation and the suspect produced a handgun and fired several rounds, which struck the victim. The suspect was described as a light skin male black with his hair pulled back in a ponytail.
