DUE PROCESS HEARING

DUE PROCESS HEARING FOR TRAVIS BUCKLEW – BUCKLEW BASEMENT WATERPROOFING & MASONRY

Travis Bucklew filed an appeal with the **City of Columbus Building Commission** regarding the Revocation of his Home Improvement Contractors license at the December 4, 2019 meeting for the **Board of Review of General/Home Improvement Contractors**. The appeal was heard on January 19, 2021. As a result of that appeal, the Building Commission remanded the Decision back to the **Board of Review of General/Home Improvement Contractors**.

Travis Bucklew/Bucklew Basement Waterproofing & Masonry was present for the hearing. Mr. Bucklew presented information requested by the Building Commission and answered questions by the Board.

After testimony and evidence presented by **Cliff Spruill, on behalf of the City** and **Mr. Bucklew, Mr. Sentic** made a motion to uphold the original decision to **REVOKE** Mr. Bucklew's license. But to remove the violation regarding **4114.111** Work of a registered OCILB Licensed Contractor and **4114.113** Work of a registered General Contractor. The violations will remain as follows: **Columbus Building Code Sections: 4113.37(b)** Building Permits Required, **4115.01** Inspections Required, **4115.03** Approvals Required, **4115.05** Inspection before covering, at the property located at 2789 Wedge Street, Columbus, Ohio. **Ken Neverman** seconded the motion.
