Incident Summary: ***UPDATE: On September 22, 2021, Corey D. McGee has been identified as a suspect in Homicide Case #2021-0156. An arrest warrant has been issued for Mr. McGee. On Sunday, September 20, 2021 at 11:21PM, Columbus Police Officers were called to the 2500 block of S. Hamilton Rd. on a report of a shooting. On arrival, officers found 29-year-old Dasia Berry suffering from an apparent gunshot wound. Madison Township Medic 183 transported Berry to Mount Carmel East Hospital in critical condition where she was pronounced deceased at 4:53AM.

Officers at the scene were directed to a nearby apartment complex where shots had been fired shortly before the victim was found. In the 4500 block of Lakeshore St. S., officers located 39-year-old Rico Williams suffering from an apparent gunshot wound. Madison Township Medic 183 transported Williams to Mount Carmel East Hospital in stable condition.

Berry and Williams were together in the 4500 block of Lakeshore St. S. when an unidentified male began shooting at the couple. After the shooting, Berry was driven to the 2500 block of S. Hamilton Rd. What prompted this shooting is still under investigation.
