**Incident Summary:**  
On Sunday, September 26, 2021, at 8:32PM, Columbus Police Officers were called to Sullivant Ave. and Holly Hill Dr. on a report of a pedestrian who had been struck by a car. On arrival, officers found a critically injured adult male. CFD Medic 12 transported the victim to Grant Medical Center in critical condition, where he was pronounced deceased at 11:46PM.

The investigation revealed that the male had been intentionally struck by a vehicle driven by 37-year-old Osman Aweys. After striking victim, Aweys fled the scene in the vehicle. On Monday, September 27, 2021, at 11:44PM, Columbus Police Officers arrested Aweys after they located him in his vehicle, asleep, in the 3900 block of Sullivant Ave. Detectives have charged murder Aweys with Murder. The decedent's name is being withheld pending notification of next of kin.
