Incident Summary: ***UPDATE***A second suspect, Mr. Raheem J. Williams, was arrested by Columbus SWAT and will be charged with Murder for his involvment in this homicide.***					

****Update September 15, 2021: A suspect, Brittany J. Weldon, was identified and arrested for her role in this Homicide. Investigators expect additional charges to be filed at later time.****

Update July 7, 2021: The victim of HOMICIDE 2021-0101 has been positively identified as Mr. Eric Jackson M/B/49 YOA.

On July 2, 2021, at 5:29am, Officers were dispatched to the area of 650 Van Buren Dr on a shooting. Upon arrival, officers located the victim, John Doe M/B, lying in a grassy area to the West of 650 Van Buren Dr. unresponsive. Medic #890 pronounced the victim deceased at 5:31am. At this time, investigators believe that an argument ensued between the victim and suspect that led to gunfire. At this time, the victim's name is being withheld until positive confirmation can be made in regards to his identity.
