**Incident Summary: \*\*\*\*Update October 18, 2021: On October 16, 2021, an Arrest Warrant for Murder was filed for the suspect of HOM2021-0163, who has been identified as, Thomas T. Henderson III M/B/22.\*\*\*\***

On October 1, 2021, Patrol Officers were dispatched to a shooting in the 900 block of Sullivant Ave. Upon arrival, Officers located the victim, Mr. Cameron Barrett M/B/21, in the alley suffering from a gunshot wound. The victim was transported to Grant Hospital by CFD Medic #10 in critical condition. Despite receiving life saving medical treatment, the victim succumbed to his injuries, and he was pronounced deceased at 11:56pm. At this time, it appears that the victim and the suspect(s) engaged in a gun battle, and the victim was struck. Investigators are attempting to locate persons of interest that were involved in this incident.
