Incident Summary: On Friday, October 22nd, 2021, at approximately 9:09 p.m., Mr. Raymond Bailey (57) of Columbus was operating a 2007 BMW 328i westbound on Dublin Granville Road approaching Karl
Road. The BMW was reportedly traveling at a high rate of speed on the wet pavement and lost control upon encountering other traffic slowing for a red light at the Karl Road intersection. The BMW veered
across the grassy center median and into the eastbound lanes of Dublin Granville Road where it struck a
2015 Toyota Camry occupied by Ms. Nabila Abdirahman (36) of Columbus. The force of the initial impact
caused the Toyota to then strike another eastbound vehicle in the adjacent lane; a 2020 Mazda CX-5 occupied by Mr. Stanley Alexander (59) of Longwood, Florida. Ms. Abdirahman was transported to
Riverside Methodist Hospital in stable condition. Mr. Alexander was transported to Mount Carmel St.
Ann's Hospital, also in stable condition. The driver of the BMW, Mr. Raymond Bailey, was transported to
Riverside Methodist Hospital in critical condition and was later pronounced dead at 9:50 p.m. on the same date.

The Accident Investigation Unit responded to the scene and initiated an investigation which is ongoing.

This was the 84th traffic-related fatality in city of Columbus, OH in 2021.
