Incident Summary: On 10/25/2021 at 10:38pm, John Doe #1 (17) of Columbus was operating a 2002 Chevrolet Tahoe northbound on Noe Bixby Rd. approaching Laraine Ct. At the same time Krystyna Woods (24) of Columbus was operating a 2007 Toyota Corolla southbound on Noe Bixby Rd. at Laraine Ct. For reasons still under investigation Joe Doe #1 veered to his left crossing the center line into the southbound lane of Noe Bixby Rd. The front of the Tahoe struck the front of the Corolla. Both vehicles came to rest north of the point of impact and west of the roadway. Fire units from Columbus responded to the crash scene. Battalion 181 pronounced John Doe #2 (30) of Columbus, the front seat passenger from the Corolla, dead at 10:50pm. John Doe #1 was transported to Grant Medical Center in stable condition. Krystyna Woods (24) of Columbus, driver of the Corolla, and Demetrius (32) of Columbus, the rear seat passenger of the Corolla, were transported to Mt. Carmel East in critical condition.

CPD Accident Investigation Unit responded to the scene and initiated an investigation which is ongoing.

2nd John Doe's identity will be released when next of kin has been notified.

This is the 86th reported fatal motor vehicle crash within the city limits of Columbus, Ohio, for 2021.
