 Columbus Downtown Connector Trail
 Kelly Messer and Brad Westall, Staff, Columbus Recreation and Parks Department (CRPD)

The Columbus Downtown Connector Trail is part of the Eastern Portion of the Ohio to Erie Trail System It will likely be undergoing trail improvements in 2022. The Recreation and Parks Department issued an RFP for design /art improvements to this section of the trail system. A proposal by the firm Epic Smalls was selected, which contains mapped locations for public art, artist proposals and artwork fees.

CRPD Staff are requesting CAC input and advice on the proposal and how best to move forward with securing public art for Columbus Downtown Connector Trail.

b) Current

Proposed Sculpture over the intersection of High and Gay Streets Edwards Companies, LLC, Applicant Don DeVere, Agent for applicant Janet Echelman, Artist

Current:

The applicant has requested an opportunity to present the public art project *Current*, for review and input prior to submitting a formal application. The project is in the process of undergoing permit review within the Department of Development. Applicants plan to present the project to the Downtown Commission for comment in December.

In January of 2020, the Edwards Companies engaged world-renowned artist, Janet Echelman, to design a signature sculpture to be suspended above the intersection of Gay and High Streets in downtown Columbus. In cooperation with DeVere LLC and the

Day Companies, owners of the buildings east of High Street, Studio Echelman, SOM and SMBH have spent the past 18 months developing the site-specific sculpture titled *Current*.

Inspired by local history and conditions, *Current* promises to be a dramatic addition to Columbus' public art scene and a regional draw combining vibrant colors and dramatic night-time illumination. The piece, like all Echelman sculptures will consist of a structural net supporting free-flowing sculptural fiber providing a kinetic experience for the viewer.
