Incident Summary: On November 14, 2021 at 1:11 a.m. Officers were dispatched to the 1300 block of Huntington Drive on a report of a person shot. Officers arrived and located M.H. suffering from a gun shot wound to the abdomen. M.H. was transported to Grant Hospital in stable condition by CFD Medics. While at the hospital, Officers were told a second victim, J. M. was dropped off at the hospital, suffering from a deep laceration to his face. It was discovered that J.M. was the suspect that shot M.H. Detectives interviewed both victims at Grant Hospital but due to their high level of intoxication, they were difficult to interview but wanted to prosecute each other. Detectives interviewed a witness at scene who stated that the two victims/suspects, were involved in an unknown argument that turned physical. Both individuals had opportunities to remove themselves from the eventual assaults, now resulting in both individuals being both victims and suspects out of the same incident.

Both victims/suspects are expected to survive their injuries. Due to the witness' statements at scene Detectives charged both individuals with Felonious Assault.
