**Incident Summary: \*\*\*\*Update December 1, 2021: On December 1, 2021, at 3:44p,m, Garland Williams was arrested by the Columbus Police SWAT TEAM for his outstanding Murder Warrant. Mr. Williams was arrested without incident and was transported to the Franklin County Jail after meeting with Homicide Detectives.**

**September 15, 2021: The suspect in Homicide 2021-0147 has been identified as Garland M. Williams M/B/45. A warrant for Murder has been filed for his arrest - Anyone with information on his whereabouts should contact the Columbus Division of Police.**

**On September 12, 2021, at approximately 5:08pm, officers were dispatched to the 1200 Block of Brookway Rd on the report of a shooting. Officers arrived at scene and located the victim who was suffering from a gunshot wound. The victim was transported by Columbus Fire Medic #23 to Grant Medical Center in critical condition but succumbed to his injuries and was pronounced deceased at 5:52pm.**
