Update November 19, 2021: Mr. Othman Adbu was arrested on his warrant without incident. Mr. Adbu was transported to local area Hospital due to a medical complaint. Upon his release he will be trasported to the Franklin County jail.

Update November 18, 2021: An arrest warrant has been filed for the suspect in this Homicide. Othman Abdu M/B/18, who is responsible for causing the death of the victim, Mr. Nazeer Winton.

On October 31, 2021, at 6:35pm, Patrol Officers responded to a shooting in the 3000 block of Rabbit Hill Lane. Upon arrival, Officers located the victim, Nazeer Winton m/b/21yoa, lying in the roadway, suffering from apparent gunshot wounds. The victim was transported to a local area Hospital by Medic #183 in critical condition. Despite receiving medical treatment, the victim succumbed to his injuries and was pronounced deceased at 7:03pm. At this time, investigators are still uncertain as to what caused this incident to occur; however, Investigators have recovered video evidence from the scene and are talking with person(s) of interest.
