Incident Summary: On January 15, 2022, Tianna Harris and another unknown female were caught stealing inside a retail store in the 1200 block of S. James Rd., when an argument between staff ensued. The argument continued outside, as Y.K. attempted to video tape Ms. Harris' vehicle information for Police. At that point, Ms. Harris began using her vehicle as a weapon, attempting to strike employees. Ms. Harris is observed on video driving in the parking lot, purposly aiming her vehicle at employees, attempting to strike them. Eventually, Ms. Harris struck M. C., causing injury resulting in M. C. being transported to Grant Medical Center. Ms. Harris then fled the scene, as Y. K. chased after her vehicle in attempt to get the vehicle registration.

A short time later, Y. K. is seen on video walking in front of a restaurant in the same blook of S. James Rd. Ms. Harris is observed to drive her vehicle directly at him from the rear of the parking lot, striking him. Ms. Harris' vehicle then continues onto the sidewalk and through the front of the restaurant, pinning Y. K. between the vehicle and the building. Ms. Harris and her unknown passenger then fled the vehicle, leaving Y. K. pinned. Ms. Harris was located about a 1/2 mile from the scene by responding Officers. Y. K. was transported to Grant Hospital for treatment. Both Y. K. and M. C. are expected to survive their injuries. Ms. Harris was charged with two (2) counts of Felonious Assault and slated at FCCCII.
