Incident Summary: On May 7, 2022, at 9:05pm, Patrol Officers responded to a shooting at the 200 Block of Ashburton. Upon arrival, Officers located the victim, Mr. Phillip Moore M/B/33, suffering from a gunshot wound. Medic 815 transported the victim to a local hospital in critical condition. Despite receiving lifesaving medical care, the victim succumbed to his injuries and was pronounced deceased at 9:37pm. Initial information received indicated that there was a domestic dispute that led to the shooting. Investigators are interviewing all persons of interest. At this time, Investigators believe that this shooting was in self defense. Upon the completion of this investigation, it will be forwarded to the Franklin County Grand Jury for review an final consideration.

This incident is still under investigation.
