**Incident Summary: \*\*\*UPDATE:** On May 11, 2022, detectives were able to link four suspects with the murder of Raquan M. Thomas. Mr. Thomas was lured to the 6000 Block of McNaughten Center under the guise of selling some marijuana. Once he arrived, Mr. Thomas was approached by four suspects who attempted to rob him of his marijuana. An altercation occurred and shots were fired at Mr. Thomas, causing his death. The other two suspects that were charged with Mr. Thomas' murder are Willie R. Mullen M/B, 21 and Zacharias O. Mullen M/B 19. \*\*\*

On May 4, 2022, at approximately 9:52pm, officers were dispatched to the 6000 Block of McNaughten Center on the report of a shooting. Officer arrived at scene and found the victim suffering from an apparent gunshot wound. Officer performed life saving measures until CFD Medic # X32 transported the victim to Mt Carmel East Hospital. Despite receiving lifesaving medical treatment, the victim succumbed to his injuries and was pronounced deceased at 10:14pm. Victim #2 was in the in close proximity of the shooting and will be considered a co-victim in this shooting. This incident is still under investigation.
